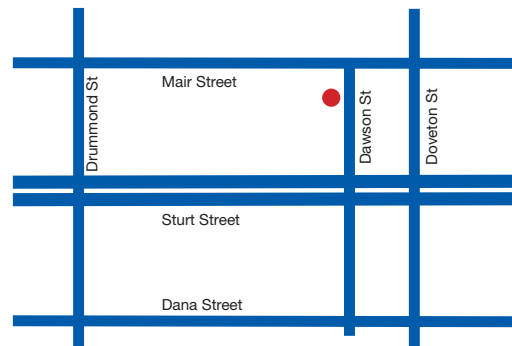
To serve the people of the Central Highlands Region, who are disadvantaged in their access to justice and work towards identifying and addressing inequalities in the law and access to legal resources
